TERMS AND CONDITIONS

PLEASE NOTE:
Participants are responsible for checking and fulfilling their own visa requirements, travel documents and insurance policies prior to travel.

OUR CONTRACT WITH YOU

From the time we receive your signed booking form and deposit, a contract exists between you and Hali Publications Ltd.

ELIGIBILITY

We reserve the right to refuse to accept a booking without necessarily giving a reason. You need to have a level of fitness which will not impact on other participants' enjoyment of the holiday by slowing them down as well as your own. You will need to be able to maintain a gentle walking pace over uneven ground as this will be a requirement for many of our visits.

INSURANCE

It is a requirement of booking that you have your own adequate travel insurance. Cover for medical treatment, repatriation, loss of property and cancellation charges must be included and policy details provided.

IF YOU CANCEL

If you have to cancel your participation on the tour there will be a charge, which varies according to the period of notice you give. Up to 8 September 2017 the tour deposit only is forfeited. Thereafter the whole cost of the tour will be due. Depending on the reasons for the cancellation, you may be able to claim the costs through your travel insurer. If you do need to cancel after 8 September 2017, we will endeavour to resell your space on your behalf (this may be at a discounted rate). If we are successful in selling your place, we will refund the sales proceeds to you less a £500 administrative charge.

IF WE CANCEL THE TOUR

We reserve the right to cancel a tour at any time up to eight weeks before departure if there are insufficient bookings for it to be viable. We will in these circumstances refund everything you have paid to us.

FINANCIAL PROTECTION

All monies for a tour are held on trust in a segregated bank account for the tour participants up until the point at which Hali Publications Limited has to make payments for the tour.

THE LIMITS OF OUR LIABILITIES

As principal, we accept responsibility for all ingredients of a tour, except those in which the principle of force majeure prevails. Our obligations and responsibilities are also limited where international conventions apply in respect of air, sea or rail carriers, including the Warsaw Convention and its various updates.

IF WE MAKE CHANGES

Circumstances might arise that prevent us from operating a tour exactly as advertised. We will make every effort to arrange a satisfactory alternative, but if the change represents a significant loss to the tour we will offer compensation. If you decide to cancel because the alternative we offer is not acceptable, we will offer a refund.

ENGLISH LAW

These conditions form part of your contract with Hali Publications Limited and are governed by English law. All proceedings shall be within the exclusive jurisdiction of the courts of England and Wales.

HOTELS

Most hotels charge more per person for a single-occupancy room than for a shared twin room since the cost of maintaining a room for one person can be almost as high as it is for two. In addition, many single-occupancy rooms are the same as twin/double rooms.

MEALS

Twelve meals and all breakfasts are provided either at hotels or select restaurants. Wine and beer will be provided with most evening meals. If you have specific dietary requirements or allergies, please tell us at the time of booking to ensure the best possible care can be taken to accommodate them. Bottled water will be supplied on coach journeys.

PAYMENT

You can confirm your place by sending us a fully completed and signed booking form, together with a deposit of £250 per person. The final balance must be paid no later than 8 September 2017.
